Attention: Bogota Vendor of Tobacco, Electronic Smoking Devices and/or Electronic Smoking Liquid:

Please be advised that the Mayor and Council of the Borough of Bogota have added a new Section 30 to Chapter 3 of the Bogota Code. Since January 1, 2020, **Ordinance No. 1531 entitled,** "Licensing of E-Cigarettes & Nicotine Delivery Devices" has been in effect. This Ordinance established new regulations governing the sale of electronic smoking devices. An electronic smoking device is defined as "an electric or other powered device that can be used to deliver Electronic Liquid, Liquid Nicotine or other substances to the person inhaling from the device, including but not limited to, an electronic cigarette, cigar, cigarillo, hookah or pipe, or any cartridge or other component of the device or related product."

Any person or business who sells an electronic smoking device within the Borough of Bogota without the appropriate license will be subject to the penalties established by law. Your attention to the foregoing is appreciated. Please contact my office if you have any questions.

FINE FOR NOT HAVING LICENSE UPON INSPECTION: \$1,200 - \$2,500
