

**Minutes of the Borough of Bogota Planning & Zoning Board Meeting  
Reorganization Meeting – January 14, 2025**

The Borough of Bogota Planning and Zoning Board held its Reorganization Meeting on Tuesday, January 14, 2024. The Election of Officers was as follows: Councilman Mitchell made a motion to re-appoint Corrado Mancini as Board Chairman with a second by Tom Napolitano. Roll was called. Motion carried. Councilman Mitchell made a motion to re-appoint Tom Napolitano as Co-Chairman to the Board with a second by Dan Schnipp. Rebecca Youla nominated Yesenia Frias with a second by Robert Foster. A paper ballot was taken with the results being Tom Napolitano as Co-Chair of the Board. A motion was made by Mayor Fede with a second by Tom Napolitano to re-appoint Patricia Morrone as Board secretary. Roll called. Motion carried.

Mayor Daniele Fede motioned to appoint Jason Shafron as Board attorney followed by a second made by Tom Napolitano. Roll called – motion carried. A motion to re-appoint Costa Engineering was made by Councilman Mitchell with a second by Tom Napolitano. Roll called – motion carried. Councilman Mitchell made a motion to appoint Paul Grygiel as Board Planner followed by a second by Tom Napolitano. Roll called – motion carried.

After a discussion led by Dan Schnipp, it was decided to have Board members comprise the Completeness Committee. The committee will consist of Dan Schnipp, Yesenia Frias and Samuel Harris.

A motion to open to public comments was made by Councilman Mitchell with a second by Dan Schnipp. There being no public comments a motion to close was made by Robert Foster with a second by Rebecca Youla. Motion carried.

A motion to adopt the minutes of the December 10<sup>th</sup> meeting was made by Rebecca Youla with a second by Daniel Schnipp. Yesenia Frias abstained. Motion carried.

There being no further business before the Board a motion was made by Tom Napolitano with a second by Rebecca Youla to adjourn. Motion carried. Meeting adjourned at 8:00 p.m.
